

Know It's NIOSH Approved

BACKGROUND

Through various sources, NIOSH became aware of instances of misleading advertising, counterfeit respirators, and false claims of NIOSH certification for filtering facepiece respirators.

Proper use of appropriate respiratory protection in environments where it is necessary – and knowing how to use it safely and effectively – is a vital line of defense against inhalation of harmful airborne particles. Equally as vital is taking a proactive role in protecting one's health and safety.

NIOSH-approved N95 filtering face piece respirators are designed specifically to provide respiratory protection with a tight seal against the wearer's face and a proven filtration efficiency for airborne particles.

OBJECTIVES

- Increase awareness of NIOSH-approved respirators
- Increase awareness of misleading advertising, counterfeit respirators, and false claims of NIOSH certification
- Outline differences in types of respiratory and facial protection devices used in healthcare
 - NIOSH-approved filtering facepiece respirators
 - NIOSH-approved and FDA-cleared Surgical N95 Respirators
 - Surgical Masks
- Explain what NIOSH-approval constitutes
- Define markings that identify a filtering facepiece respirator as having NIOSH-approval
- Provide an accessible list of NIOSH-approved respirators
- Provide an accessible list of products that have had approval revoked as well as false claims on the market

METHODS

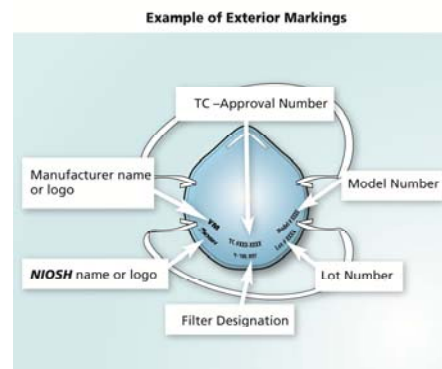
- Public service campaign enacted

- List of revoked / rescinded NIOSH-approved respirators expanded to include model numbers and private label names



RESULTS

- OSHA video developed to support public information campaign http://www.osha.gov/video/respiratory_protection/index.html
- Informational brochure developed to inform respirator users of misleading advertising and counterfeit products
- Banner stand will make its debut at the 2012 Association of Perioperative Registered Nurses (AORN) Conference during which time NPPTL staff will have the opportunity to speak with nurses who use respiratory protection on a daily basis. In addition, OSHA video will be shown at the NIOSH exhibit during the AORN conference.
- Efforts to disseminate information are ongoing
